Healthcare Reform Changes Begin

You or your family members may qualify for one of the following one-time special enrollment opportunities outlined under federal healthcare reform law. As group and individual policies renew on or after September 23, 2010, we will mail notices to affected members and employers to provide details and enrollment deadlines.

Extension of Dependent Coverage to age 26.

Individuals under age 26 who do not have healthcare coverage because they reached the previous dependent age limit or were over the previous age limit may be eligible to enroll. Children who meet the qualifications are eligible to enroll or re-enroll as dependents. Enrollment is effective on the plan's renewal date on or after September 23, 2010.

Lifetime limit no longer applies. Individuals whose coverage ended by reason of reaching a lifetime limit under their plan, but are otherwise eligible under the terms of the plan, are eligible to re-enroll in their plan. Enrollment is effective on the plan's renewal date on or after September 23, 2010.

Pre-existing waiting period no longer applies to under age 19. If a member under age 19 is currently in a pre-existing condition waiting period, the period will



automatically end as of your plan's renewal date. You will not need to take any action.

Flu Vaccination Coverage Update

This year's combined flu vaccine will cover H1N1, the seasonal influenza B, and a new strain, H3N2. Effective October 1, 2010, we will also expand the number of pharmacies participating in our flu shot clinic pharmacy network.

Coverage for Flu Shot Clinics at Our Participating Flu Shot Pharmacy Network

If your plan has a pharmacy benefit, you can obtain a flu vaccine shot from our participating Flu Shot Pharmacy Network. Simply show your PacificSource member ID card at one of the following participating flu shot clinics to receive a flu shot at no cost! PacificSource will be billed directly, with no paperwork, deductibles, or copayments required.*

Pharmacy Chains (as of October 1): Albertsons, Bi-Mart, Costco, Fred Meyer, Haggen, Hi School, Kmart, Kroger, QFC, Rite Aid, Rosauers, Safeway, Shopko, Target, Top Food, and affiliated pharmacies.

Know a child in need of health insurance?



Uninsured children now have access to coverage through Healthy Kids. The goal of Healthy Kids is to make sure Oregon children have health coverage. Depending on your family income, your uninsured child may be eligible for free or low-cost health coverage through this program. Healthy Kids can provide:

- Healthcare for children age 18 and younger
- Free or low-cost health care based on income
- Coverage, even for children with a medical condition
- Medical, dental and vision care; regular checkups; preventive care; prescription drugs; mental health and chemical dependency services; and medical equipment and supplies

The program application process is different than when applying directly to a carrier. Applicants first apply through the Oregon Health Plan (OHP). If applicants don't qualify for OHP, they can then choose and apply for a Healthy Kids plan.

- Even kids with current health conditions can enroll.
- Coverage lasts for at least one full year and can be longer, so long as the child is still eligible.
- Program eligibility is based on family income and there are three health coverage options: no-cost, low-cost, and affordable.

PacificSource, and our subsidiary Clear One, are pleased to participate as carriers in this program and look forward to welcoming these new members. It's another way we're working to make healthcare more accessible to families.

Flu Vaccination Coverage Update, continued Flu Shot or FluMist Available Under Your Medical Immunization Benefit

PacificSource also provides coverage for standard flu shots, high-dose flu shots, and flu nasal mist under your medical plan's immunization benefit.*

- County Health Departments: Covered at the participating provider benefit level; applicable deductibles and copayments apply.
- Physician's Office: Covered subject to participating and nonparticipating provider provisions. Applicable deductibles, coinsurance, and maximum allowances apply.

Note: Under healthcare reform, deductibles and coinsurance will eventually be waived for flu immunizations from participating providers. This change becomes effective at your insurance policy's next annual renewal date on or after September 23, 2010 (grandfathered plans excluded). To find out when this change will apply to you, check with your employer or contact PacificSource Customer Service.

Community Health Excellence Program Makes an Impact in Your Area

In 2009, we launched an innovative program to encourage collaborative community health solutions. Our Community Health Excellence (CHE) program provides funding for provider initiatives designed to ensure high quality care for all patients—not only PacificSource members, but also those covered by other insurers or without any coverage.

A year later, we are thrilled to be funding 24 innovative provider organization initiatives throughout Oregon and Idaho. Playing a role in patient care improvements and having a positive impact on community health is important to us. Our CHE program is working in your area through the following initiatives:

Peace Health Medical Group, Eugene
PacificSource will help fund on-site psychiatry services to help with access issues for those with immediate psychiatric needs.

Samaritan Health Services, Corvallis
Funding from PacificSource will help establish a program to monitor and combat pediatric obesity at all schools in the Linn, Benton, and Lincoln counties.

South Lane Medical Group, Cottage Grove
Funding from PacificSource will help their primary care team add a full-time pharmacist to ensure safe, effective, and clearly understood medication therapy management.

Oregon Neurology Associates, Eugene
Funding from PacificSource helps develop and maintain a mini-stroke (TIA) clinic to ensure diagnosis and treatment of TIAs within 24 hours to prevent subsequent full strokes.

Oregon Medical Group, Eugene
Funding from PacificSource helps pay for patient outreach and education to encourage routine preventive care screenings for breast cancer, cervical cancer, colorectal cancer, and diabetes.

Northwest Specialty Clinics, Eugene
PacificSource helps fund nurse patient care navigators to guide cancer patients through the diagnosis and treatment process and ensure they receive protocol-based, expedited cancer care.

Women's Care, Eugene
Funding from PacificSource helped establish standardized chlamydia education and screening intervention for young women.

Salem Hospital, Salem
Deep Vein Thrombosis (DVT) and Pulmonary Embolism (PE) conditions can pose a serious risk for hospitalized patients. Funding from PacificSource will provide for comprehensive DVT and PE risk assessments through the addition of a part-time RN coordinator.

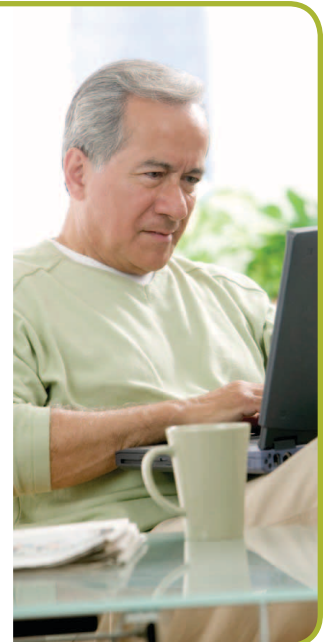
